ACKNOWLEDGMENT AND DECLARATION OF CONSENT

- c. To learn the third persons/parties in country or outside if your personal data are shared with them,
- d. To request for corrective action in case that your personal data are missing or processed with error,
- e. Requesting your data to be deleted completely and/or made anonymous in case that the reasons to process your personal data are not valid or applicable anymore as per Article 7 of PDPL,
- f. To request an update to be sent to the third persons/parties in case that paragraph (d) and (e) are effectuated,
- g. To challenge/object any adverse condition or situation that results in against you in case of any exclusive analysis of your personal data processed by automatic systems,
- h. To request for compensation for any damages caused by mishandling or misuse of your personal data or processing of them against the law.

All the requests that are submitted properly are responded and finalized by AYJET within 30 days.
